Section 2 - Order Details

A pet needs an AHC in one of the official languages of the EU Member State through which it will enter the EU. For example, a pet entering the EU in France would need a French AHC. All AHCs, except the English AHC, are dual language (they are written in English as well as another language). You will be issued with 50 AHC Unique Certificate Numbers.

An AHC can only be issued by an Official Veterinarian (OV) who holds the appropriate Companion Animal (CA) or Small Animal (SX) Official Controls Qualification (Veterinarian) OCQ(V) and is duly authorised by APHA (refer to the Improve International website, www.improve-ov.com). AHC Unique Certificate Numbers will only be sent to practices which have a qualified OV.
